### CSU Fresno GE Certification- COVID 19

Fresno State will be accommodating requests from community college counselors who are responsible for issuing CSU GE or IGETC Certifications who are telecommuting and need an alternative way to provide us with GE certifications. If you are still able to send us the GE certifications through the mail then please continue this practice. It might take longer to reach our office as even our mail services have been impacted by COVID-19. We are providing you with the contact information of our transfer advisors so GE or IGETC certifications can be sent directly to them.

1. GE certifications must include the name of the community college certifying the coursework. An electronic signature from the community college counselor is acceptable along with the date.
2. GE certifications must come directly from a community college counselor's work email address.
3. GE certifications are to be in a PDF version and attached to an email sent directly to our transfer advisor working the student file. *See attached advisor list.*
4. **If** a PDF copy cannot be attached and sent via email, Fresno State will accept a picture of the GE certification as long as there is a clear image. These GE certifications will replace the hard copy that Fresno State normally would require. A clear image is required for recordkeeping.
5. Please provide the student's full name, month, and day of birth and Fresno State ID if available. This will assist Fresno State in identifying the student correctly.
6. The GE certification must show clearly the school name, course prefix and course number of the course being used to fulfill a GE area or the external exam type and subject title.
7. For partial GE certifications, Fresno State asks for a minimum of at least a full GE area, such as all of Area A.
8. Please note after COVID 19 shelter in place is lifted Fresno State will require GE certifications as we have in the past.
