Provost W. Covino sent Chair J. Constable a memo on October 8, 2009 indicating that due to changes in her responsibilities Associate Provost E. Junn would no longer be serving as the Provost's designee on the University Budget Committee (UBC). This role will be adopted by John Waayers.

4. New Business.

The UBC was made aware of a concern regarding gifts to the University that support academic programs. Apparently, these gifts are having the cost of faculty benefits (health insurance etc.) subtracted from the gift while a faculty member works on the gift's academic goals. It was decided to make this a future topic of examination by the UBC at which Dr. T. McClanahan will be requested to appear.

5. Parking Office Income and Expenses – Update.

An initial set of questions regarding the budget of Parking-Traffic Operations will be sent to members of the UBC for comments and additions. There was concern voiced by UBC members over the pace of the increases in the student parking fee. Discussion also identified that the University is seeking to increase the role of distance and on-line learning options offered to students, yet there are plans to construct multiple multi-level parking structures on campus – how can the University justify increased parking charges for new parking structures when a goal of the university is to promote off-campus learning options?

6. Review of Academic Programs - Update.
